PUBLISHING WITH WILEY-IEEE PRESS

WHEN SHOULD I TRY TO FIND A PUBLISHER FOR MY BOOK?

If you have identified an area in which you have expertise, believe you have something original to contribute, and have a clear idea of what you want to write, then Wiley-IEEE Press would welcome a proposal from you. Please use the guidelines found online at www.ieee.org/press.

WHY SHOULD I CHOOSE WILEY-IEEE PRESS FOR MY BOOK?

The collaboration between Wiley and IEEE takes full advantage of the global reach of these two large international organizations to maximize sales. Wiley's worldwide marketing reach, coupled with the outstanding professional credibility and visibility of the IEEE and the Magnetics Society, combine to provide excellent marketing exposure. For authors, this leads to increased name recognition and enhanced professional standing.

HOW LONG DOES IT TAKE TO MAKE A PUBLISHING DECISION?

Once the proposal and sample materials are received it takes about 4-6 weeks to secure proposal reviews, another 2-3 weeks for the proposer's response to the reviews to be prepared, and the project financial and marketing prospectus to be generated and presented, and another 2 weeks for contract negotiation and signing. From beginning to end, the process takes about 2 - 3 months, although times vary.

WILL I BE PAID A ROYALTY?

Competitive royalty rates for the authors are determined during the contract negotiation phase.

WHAT KINDS OF BOOKS ARE WILEY-IEEE PRESS LOOKING FOR?

A list of cutting-edge or under-served areas where we believe there is both an interest and need for new books is on the back of this brochure. However, we welcome proposals for topics not on the list.

HOW DOES WILEY-IEEE PRESS SUPPORT AUTHORS DURING THE WRITING PROCESS?

We only contract with authors after a thorough review of the proposal. Once the manuscript is complete, it undergoes technical review prior to acceptance for publication. The technical reviews are commissioned by IEEE Press staff and volunteers, who liaise with the Magnetics

Society to identify appropriate reviewers to provide guidance to the author. The same high quality standards of all IEEE publications are observed for IEEE Press books. If the first draft is not acceptable, revisions are requested from the author, and the material is reviewed again. As long as authors make good-faith efforts to address the technical and market concerns identified by the reviewers, we continue to work with them to develop a high quality book.

DOES WILEY-IEEE PRESS OFFER FULL PRODUCTION SERVICES?

All Wiley-IEEE Press books are professionally copyedited once they have been accepted for publication. We also offer our authors full production services, including art preparation, page make-up, and collaboration on other aspects that affect the aesthetics of the printed book. For authors who wish to provide camera-ready manuscript, templates for this purpose are provided by Wiley.

WHO HOLDS THE COPYRIGHT IN THE BOOK? HOW IS IT "BRANDED"?

Authors contract with the IEEE Press to grant the IEEE copyright on the published work. The IEEE Master Brand appears at the top of the spine and the Wiley Colophon at the bottom. Both brands appear elsewhere on the cover and inside the book. If the book is in a series, the series brand and identification appears on the cover and title page. If an IEEE Society sponsors the book, that information appears on the title page.
